## **BY-LAW NO. 2021-24**

As we approach 2021, it has become clear that, unfortunately, COVID-19 will see us postponing Manitoulin Country Fest and Rockin' The Rock again this year.

We are looking to pivot to create opportunities that provide entertainment with economic impact to our region in a safe, COVID mindful environment. In 2020, a Sudbury business rented our grounds to host two drive in concerts. Both of these were well attended, easy to manage and resulted in zero COVID-19 cases.

As we look to this summer, we are working with another partner to host a North Shore Concert Series. The intention is to host six (6) drive in concerts, some even in a festival multi-day format. We will continue to work closely with Public Health Sudbury & Districts to ensure safety of our patrons, volunteers and artists are top of mind. As a matter of interest, we have already met in person at the grounds with a Public Health COVID Inspector to access the viability of the venue. Please note, we will be limiting capacity at 500 or less persons as per current recommendations from the Health Unit. We will continue to monitor the ever changing landscape to ensure we are compliant at all times.

On the basis of the above, we are requesting from Mayor and Council the following:

- 1. Designate the North Shore Concert Series for the summer of 2021 as an event of municipal significance;
- 2. Supply all available picnic tables (free of charge) to the venue for use in front of the stage. We will provide the town staff with one week's notice of the date;
- 3. One, possibly two nim buckets per event (free of charge);
- 4. Placement of directional signs on municipal property two days prior to each event;
- 5. Inclusion of the North Shore Concert Series on the Town of NEMI LED sign, inclusion on NEMI website and NEMI marketing.

Thank you to Mayor and Council for your support and we look forward to a safe and economically lively summer for NEMI for 2021!
