Wayne, this will confirm our telephone conversation this morning about traffic issues at the new Tim Hortons and at the intersection in Sheguindah. I am offering my initial thoughts without actually observing the problem on site and without relevant data or detailed information from you and Ian. If after you have reviewed this email, you would like me to meet with you out at the sites, I would be pleased to do so.

1. Tim Hortons

The problem is the Tim Hortons drive-through queue backing out onto the street and blocking through traffic southbound on Hwy 6/Manitowaning Road. One option would be to shift the through lanes eastward using the parking lane on the east side for the northbound through lane, thereby freeing the current southbound lane to become a right turn lane into the Tim Hortons.

My initial thought is that, while northbound traffic and northbound left turns into the Tim Hortons are very low at this time, in the summer that will change and we may regret not having the parking lane for accommodating northbound traffic.

My initial recommendation would be to do a physical widening of Manitowaning Road on the west side from Blake Street southward to provide a taper and right turn lane into the Tim Hortons.

2. Sheguindah

The four-way intersection has two approaches on a steep grade. Town staff have installed STOP signs on two approaches and a YIELD sign on a third approach. This configuration is a problem from a legal and liability point of view. My initial recommendation would be to place YIELD signs on the downhill and uphill approaches only, leaving the other two approaches uncontrolled.

Staff experience with the intersection will be important in finalizing a recommendation.

Dear Mayor MacNevin:

Thank you for the email regarding the foghorn on the Little Current Swing Bridge.

The Little Current Swing Bridge crosses navigable waters, and is required to comply with applicable federal and provincial legislation, and is outfitted with visual and audible warnings for passing boats. In low visibility conditions such as fog, the foghorn is used to advise passing boats of the bridges presence. The Little Current Swing Bridge center pier is located in the middle of the navigable channel and is a hazard to passing boats.

The existing foghorn on the Little Current Swing Bridge was recently identified to not be functional, and required replacement. The new foghorn is automatically activated when it senses fog, and does not require manual activation.

The ministry has consulted with the Coast Guard, Transport Canada, and provincial agencies; and have been advised that municipalities, through noise bylaws can regulate the use of foghorns.

The ministry is open to working with the Town of Northeastern Manitoulin and the Islands, and further discussing the operation of the foghorn on the Little Current Swing Bridge.
